
# The Group Introduction

Al-Noor Group of companies began operations as a trading company in the late Nineteenth Century in Calcutta, India. Offices were subsequently established in Mauritius, Sri Lanka and Burma that specialized in Sugar, Rice & Jute trade.

Post sub-continent partition, the Group established Noori Trading Corporation (Pvt) Ltd. in Karachi, Pakistan to handle the trading of general merchandise and in 1960 Noori Sugar Factory was established with a cane research farm in Moro/Nawabshah District along with a small sugar manufacturing unit.

In 1971 Al-Noor Sugar Mills Limited was commissioned and subsequently listed on the Karachi Stock Exchange. The principle activities of the Company are manufacturing Sugar, Ethanol & Medium Density Fibre (MDF) board, power generation and its sale.






